A closer look at the honor

THE IMPACT AWARD

Miles of Smiles was recently honored by the Oral Health Forum at the American Dental Association headquarters in Chicago. The "Impact Champion" award was given to MOS in recognition of their work in Chicago Public Schools as well as their work statewide. The Oral Health Forum was created to expand equitable access to oral health care in medically underresourced communities. The Champions award is presented to networking partners who have the most impact in achieving the OHF mission. Accepting the award were Dr. David Trost of Taylorville, owner and President of MOS, Dr. Kevin Gibbs of Chicago, Dr. Philip Nelson of Chicago, Lorna Schlink, RDH of Metamora, and Nikki Carls, RDH of Pana. Dr. Trost gave a few acceptance remarks on behalf of his team, which includes approximately 50 seasonal oral health professionals. Dr. Trost included the schools and their staff as recipients of the award as well, saying they make the school-based program possible by encouraging student participation, by supplying the space and furniture needed for the set-up, and by providing help in obtaining the children from their classrooms. In addition, he acknowledged the collaboration with many agencies for the needed follow-up care. Dr. Trost requested that all community stakeholders network together often to influence increased funding for the dental care of lower income families. Access to quality oral health care is a very difficult problem for these children and their families. It was noted that the school program is not intended to compete with office based dentists. However, recent changes in the rules of compensation have made it difficult for both the school-based and the office-based dentists. "We must take 'yes' for an answer" is the ongoing theme in talking with our legislators.

ATTENTION: REQUIRED DENTAL EXAMINATIONS per the Illinois State Board of Education:

- All Illinois children in kindergarten, grade 2, grade 6, and grade 9 are required to have an oral health examination.
- Regarding 9th grade dentals going into effect on 1/1/19. It goes into
 effect for the new school year the 2019/2020 school year.
- This is required for all public, private, and parochial schools.
- Examinations must be performed by a licensed dentist, and he/she must sign the Proof of School Dental Examination form.
- Each child is required to present proof of examination by a dentist prior to May 15 of the school year.
- The dates in the rules were set so the exam is valid for 18 months.
