



## Infection Prevention Control: Top Notch!!



Miles of Smiles, Ltd. partners with the Illinois Department of Healthcare and Family Services and the Illinois Department of Public Health Division of Oral Health (IDPH). IDPH routinely conducts surprise site visits to all of our dental teams. These quality control visits provide assurance that we are following the Infection Control guidelines recommended by the Centers for Disease Control and Prevention (CDC) and by the Occupational Safety and Health Administration (OSHA). Miles of Smiles, Ltd. is committed to treating each child with compassion and respect. Our licensed dental professionals are dedicated to providing the best possible oral health care, consistently utilizing top of the line infection control. We always have and always will provide each child/patient with the recommended standard precautions.

Standard Precautions are the baseline of infection prevention practices that apply to all patient care. They are applied regardless of suspected or confirmed infection status of the patient and applied in any setting where health care is delivered. These practices are designed to both protect the Dental Health Care Provider and the patient. They are necessary to prevent the spread of infection among patients.

Standard Precautions include— 1. Hand hygiene. 2. Use of personal protective equipment (e.g., gloves, masks, eyewear). 3. Respiratory hygiene/cough etiquette. 4. Sharps safety (engineering and work practice controls).

5. Safe injection practices (i.e., aseptic technique for parenteral medications). 6. Sterile instruments and devices. 7. Clean and disinfected environmental surfaces.

Miles of Smiles, Ltd. also uses mechanical, chemical, and biological monitors according to manufacturer instructions to ensure the effectiveness of the sterilization process for our Autoclave (sterilizer) and also of our dental units to make sure we have the safest quality of water. We maintain sterilization records in accordance with state and local regulations.

We have all been worried, stressed, and scared through the COVID-19 Pandemic. Miles of Smiles, Ltd., assures you that we are practicing, to the best of our ability, to protect our patients and our clinicians. We will continue to follow and update all of our guidelines as we are recommended by the CDC and by OSHA, to protect all that we serve.


